The **Kawasoti Municipality, Office of Municipal Executive, Kawasoti, Nawalparasi, Nepal** has allocated funds Towards the cost of Project "**Construction of Ring road(Blacktopped Premix construction)**" with estimated amount **NRs. 1,54,83,501.87 (Without VAT)** and intends to apply part of the funds to cover eligible payments under the Contract for the Contracts as mentioned below. Bidding is open to all eligible Nepalese and Foreign Bidders.

2. **Kawasoti Municipality, office of Municipal Executive, Kawasoti, Nawalparasi, Nepal** electronic bids from eligible bidders for the construction of "**Construction of Ring road(Blacktopped Premix construction)**" under National Competitive Bidding Single stage Single Envelope Bidding procedures. Only eligible bidders with the following key eligibility criteria **as per clause 40(2) of PPR 2064** should participate in this bidding.

4. Bidders, to submit their bid electronically download the bidding documents for e-submission from PPMO's Web Site **www.bolpatra.gov.np/egp**. Bidders, submitting their bid electronically, should deposit the costpayment of a non-refundable fee of **NRs. 3000.00 for bid document till 2075/02/04 (18th May, 2018)** in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Sealed or electronic bids must be submitted through PPMO website **www.bolpatra.gov.np/egp** On or before **12.00 noon on 2075/02/06 (20th May, 2018)**. Bids received after this deadline will be rejected.

6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2.00 PM on 2075/02/06 (20th May, 2018)** at the **Kawasoti Municipality, Office of Municipal Executive, Kawasoti, Nawalparasi, Nepal**. Bids must be valid for a period of 90 days after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 4, 40,000.00**, which shall be valid for 30 days beyond the validity period of the bid.

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. If the specified date for last date of submission & opening falls on a government holiday then the same time on the next working day shall be considered for such events. In such case the validity of bid security shall be considered from already specified last dates for bid submission.

9. Each bidder shall bid only one bid, either individually or as a partner in a J/V. To facilitate contract administration, the number partners in J/V is limited to three.

10. The bidders are advised to visit the site & assess the actual site condition before submission of bid document.

11. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.

12. All other terms & conditions will be as per prevailing procurement act & regulations of government of Nepal & local body financial administrative regulation.
